Queries are received with reference subject cited above wrt Advertisement No. – 02/12/2021. The following clarification should be noted in this regard:

1. The minimum Education Qualification for the **post code – 0212202107** (Lecturer (Computer Engineering (Computer Application/Computer Engineering/ Computer Science/Information Technology Enabled Services And Management)) is:
Master's in Engineering/Technology (M.E./M.Tech.) in Computer Science & Engineering or in relevant branch.
2. The minimum Education Qualification for the **post code – 0212202118** (Assistant Professor (School of IT and ITeS (Computer Applications / Data Analytics & Data Science)) is as per UGC norms which is reproduced as:

Eligibility (A or B) :

A.

- (i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in Computer Science or relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET.

OR

- B.** The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).
