- iii) The Institute shall charge the provisional fee equivalent to Electronics & Communication course for A+ category Institute for the course of IC Manufacturing.
- iv) The Institute is directed to submit the Sanctioned Building Plan.

Further, review shall be done after 3 months and their request for extension of further affiliation shall not be considered from the academic session 2024-2025 in case the compliance of the above directions is not submitted.
